**Applications must be completed and submitted electronically through the Centralized Wait List online application portal, accessible at [www.waitlistcentralri.com](http://www.waitlistcentralri.com). The application portal will be available beginning Sunday, December 17, 2017 at 12:01 a.m., and will remain open indefinitely.**

Rhode Island Housing's electronic application portal is the sole method of submitting an application. Computer terminals and staff assistance will be made available to applicants at participating community organizations. The hours and locations of such organizations will be available on the Rhode Island Housing website ([www.rihousing.com](http://www.rihousing.com)) beginning December 1, 2017.

To be determined “conditionally eligible” and placed on one or more waiting lists, applicants must fall within each agency’s maximum annual income limits for their household size. Conditionally eligible applicants will be placed on the applicable waiting lists based on the date and time that they apply and any selection preferences established by each housing authority. Existing applicants who applied to the Rhode Island Housing and/or Providence Housing Authority HCVP waiting lists in November 2016 may submit an application to the other participating housing authorities listed above using their existing account at [www.waitlistcentralri.com](http://www.waitlistcentralri.com). However, do not submit a new application to Rhode Island Housing or Providence Housing Authority; duplicate applications will be automatically rejected.
