As to 224 Pearl Street and 34 Hayward Street, these parcels had previously been part of the Barbara Jordan II portfolio, but the titles are unclear currently. RIHousing is actively pursuing title clearing actions in Superior Court and if these actions are successful, both properties would be available for redevelopment.
