Please note RIHousing is undertaking to include a portion of the land that is a paper street also known as 1 Vine Street, but that at the time of the preparation of the RFP, the negotiations are ongoing with the City of Providence, so we cannot confirm yet that the land will be includable in the project. As to 224 Pearl Street and 34 Hayward Street, these parcels had previously been part of the Barbara Jordan II portfolio, but the titles are unclear currently. RIHousing is actively pursuing title clearing actions in Superior Court and if these actions are successful, both properties would be available for redevelopment.
