This Notice shall satisfy two separate but related procedural requirements for an activity to be undertaken by Rhode Island Housing and Mortgage Finance Corporation (“RIHousing”).

REQUEST FOR RELEASE OF FUNDS

On or about November 22, 2023, RIHousing will submit a request to the U.S. Department of Housing and Urban Development for the approval of FHA Risk Share Insurance for the following project:

The Central Street Development Apartments project proposed by Pawtucket Central Falls Development Corporation (PCFDC) consists of two separate components, new construction, and preservation of existing rental units with rehabilitation, on 12 scattered sites in both Pawtucket and Central Falls. The first component of the project is new construction on the vacant, blighted parcel of the former American Legion Post, with demolition planned for the current building, to construct a single, 3-story building containing twenty-five (25) units mixed-use/mixed-income housing units and two (2) commercial units for community service facility spaces of a Homeownership Center and Tech Hub for resident and community use. The other new construction site will contain five (5) three-bedroom units. The preservation and rehabilitation component contains thirty-two (32) units located on ten (10) scattered sites. The total sixty-two (62) rental units will range in size from one-bedroom to four-bedroom units and are proposed to serve tenants between 30% AMI and 80% AMI households. This project proposal for new construction and preservation financing with a loan that will be insured under the HUD Risk Sharing Program creates much needed affordable housing in Pawtucket and Central Falls.

FINDING OF NO SIGNIFICANT IMPACT

Rhode Island Housing has determined that this project will have no significant impact on the human environment. Therefore, Environmental Impact Statements under the National Environmental



Policy Act of 1969 (NEPA) are not required. Additional project information is contained in the Environmental Review Record (ERR) on file at Rhode Island Housing, 44 Washington Street, Providence, RI 02903 and may be examined or copied weekdays from 10 A.M. to 3 P.M. PUBLIC COMMENTS

Any individual, group, or agency wishing to comment on the project may submit written comments on the ERR to RIIHousing. All comments received by November 21, 2023, will be considered by RIIHousing prior to authorizing submission of a request for release of funds. Comments should specify the Notice they are addressing.


RELEASE OF FUNDS

RIHousing certifies to HUD that Carol A. Ventura, in her capacity as Executive Director consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows RIIHousing to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of funds and RIIHousing's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of RIIHousing (b) RIIHousing has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted via email in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to HUD at Department of Housing and Urban Development, Office of Community Planning and Development, at: CPD_COVID-19OEE-BOS@hud.gov.

Potential objectors should contact HUD at Department of Housing and Urban Development, Office of Community Planning and Development, via email to verify the actual last day of the objection period.
